While employed as both an Immigration Enforcement Agent, in Boston, Massachusetts, and a Deportation Officer, in Orlando, Florida, I have made hundreds of criminal arrests and thousands of administrative arrests throughout my fourteen years of federal service. Of those I arrested, I regularly inquired as to whom they voted for in the last election. While very few illegal aliens ever admitted to voting in the national election, I was surprised at how many lawful permanent residents admitted to voting in the national election. When lawful permanent residents were informed that they were not authorized to vote in the national election, many claimed they were not aware. When pressed to explain further, many simply stated that they were provided a ballot, made their selections on the entire ballot, and returned the completed ballot.

Curious, I looked into this matter further and discovered that, in Florida, lawful permanent residents are considered residents of the state and allowed to vote in state elections and for state measures effecting their wellbeing. While these lawful permanent residents are not allowed to vote in the federal election, both federal and state election measures are contained on the same ballot form. In the most recent national election, I took a few extra minutes to examine the ballot I was provided to see if there was a clear distinction between federal and state election measures. I noticed that the national election measures were listed first followed by state election measures; however, I did not immediately

recognize any clear distinction between the federal and state ballot measures nor did I notice any bolded warnings to non-U.S. citizens solely casting their vote on the state election measures.

With the lawful permanent resident population within the U.S. about 13.2 million (January, 2014), I believe the Presidential Advisory Commission on Election Integrity should look into how many of those 13.2 million lawful permanent residents are voting in the national election. Furthermore, in those specific states that allow illegal aliens to vote in their state elections, the commission should also look into how many how many of those illegal aliens are also voting in the national election. It is my personal and professional opinion that the only way to significantly reduce the number of legal and illegal aliens voting in the national election is to separate the state and federal ballots and merely ask voters if they are U.S. citizens prior to handing them a national ballot on election day. I also believe that we should prosecute those legal and illegal aliens that voted in previous national elections; however, Immigration and Customs Enforcement would need the commission's assistance in obtaining the evidence required for a criminal prosecution as most states are reluctant to turn over prior election ballots.

As a current federal employee, I discussed my observations, perspective, and suggestions with my supervisor and received permission to forward my comments to this commission.

We got in touch with the voter registrar in Clarke County, Virginia (Berryville) to find out the process for getting Jarrett the absentee ballot. After Ms. Bosserman received it, she would then mail him an absentee ballot to his school address.

When the Trump administration issued the Executive Order to review the 2016 voting process, it was assumed that the target would be non-Americans. Sadly an American citizen, Corry Westbrook, accumulated a solid record of voter fraud. There is a solid record that documents her illegal actions. It is now public knowledge that the Florida Department of Law Enforcement performed a criminal investigation and recommended that Corry Westbrook be arrested and prosecuted for voter fraud. This report is identified as FP-32-0002.

The Florida Application for Voter Registration form DS-DE 39 form clearly documents that the person seeking to vote in Florida is a legal resident of Florida. Violation of Florida law is a third degree felony and a \$5,000 penalty.

No Florida official has made a decision on the arrest and prosecution of Corry Westbrook.

In 2016 the Florida Division of Elections published "2016 Florida Voter Registration and Voting Guidelines. This identifies the requirement to reside in the county where they intend to vote. In the Corry Westbrook situation, she had never lived in Leon County.

As we learned in the Watergate era, following the money will identify the crimes committed.

In the case of Corry Westbrook she obtained a homestead exemption in order to reduce the costs of living in Washington, D. C. She also paid taxes on her property.

Corry Westbrook also was in violation of Florida law by making false claims to obtain a Florida Drivers license

There is no evidence in the Florida Department of Motor Vehicles that Corry Westbrook ever bothered to register her automobile in Florida. By following the money trail, it is clear that Corry Westbrook still has an automobile registered in Washington, D. C.

To the Commission:

Although I have, as a civic-minded voter (not "involved" in politics extensively, but who follows events, reads, votes and tries to impart to voters their obligations to vote) been a Republican Election Judge since 1986 , I was not assigned as a Judge this past Election.

He replied: "we have to take them at their word" -

So, conceivably, Jones gets his ID - but "Jones" can also possess another ID under another name. It's not surprising that "homeless voters" are sometimes bused to Polling Places.

Am I certain of any fraud? NO. However, this seems fishy. Every citizen should be able to vote, and yes, "homeless" included. But my own research shows that the ones who get those ID's are not willing to talk about whether they voted or not.

My theory [my belief, even] is as follows:

A few years back, Judges handled books filled with the voters' names. During one Primary Election, the two large books, and the "registered voter" rolls, contained 500 or so names - BUT only 35 voters turned up.

One would assume that this shows indifference and apathy.

But my concern is that, within the books are non-existent names. They serve as a sort of "stacked deck" for a Political Party to "use" when need arises in, say, a certain Precinct where a turnout is crucial. In a reassuring announcement, Republican lawmakers are poised to increase the scope of their ongoing search for wrongdoing at federal agencies in the past election cycles. This news comes after learning that the United States Postal Service broke the law by allowing employees to conduct union-funded work for Hillary Clinton's campaign while they were on leave, according to Fox News.

In response to this shocking revelation, lawmakers sent out letters Monday to 10 other Federal government agencies questioning their unpaid leave policy for political work.

This news has emerged in light of a previous congressional hearing back in July, during which the Office of Special Counsel stated that the USPS was engaged in "systemic violations" of the Hatch Act—a law that limits certain political activities of federal employees.

The report that first came out over a month ago said the US Postal Service showed bias towards the Clinton campaign. Senate Homeland Security Chairman Ron Johnson (R-WI), said, "based on these findings, it is legitimate to wonder why no one will be held accountable, how Postal Service leadership

allowed this systemic violation of the Hatch Act to go on for twenty years and is this occurring in other federal agencies?"

The scandal was first brought to Johnson's attention by Tim Kopp, a letter carrier for the USPS, who thought that the federal agency's actions might be "illegal."

"I want things done fairly and I don't want things done on a partisan issue – the union is always involved in highly political activities and I didn't want this to be a partisan thing – I wanted this to be a thing where the general public does not lose trust in the postal service. There are a lot of good employees, but the way this was done – it was a nightmare," Kopp said.

This investigation had revealed that this bias extended potentially as far back in the 1990s, a shocking violation considering that as a federal entity, the USPS needs to remain politically neutral. This is especially true considering the Postal Service is many citizens' primary method of contact with the Federal government.

Johnson, alongside with House Oversight Committee Chairman Trey Gowdy (R-SC), wrote joint letters to the departments of Commerce, Homeland Security, Defense, Justice, Labor, Transportation, Treasury, Agriculture, Veterans Affairs, and Social Security Administration. The duo requested information regarding the "use of LWOP in the three months prior to a federal election" all the way back to 2008 when Obama first got elected.

This data—demanded on a state-by-state level—is due September 11th for further review.

These cases are a testament to just how deeply entrenched some of these election-rigging tactics have become. Digging out this one violation was pain-staking. It had stayed hidden for over 20 years.

Now that the Trump administration is taking voter fraud seriously, there is finally hope that these types of voting violations will cease and that widespread voter fraud is combatted routinely from this day forward.
