

Designation of Funding as an Emergency Requirement

Congress designated as an emergency requirement all funding in division A of the Additional Supplemental Appropriations for Disaster Relief Requirements Act, 2017 (H.R. 2266; "the Act"). Section 304 of division A of the Act provides that the availability of funding that is designated by the Congress as an emergency requirement pursuant to section 251(b)(2)(A) of the Balanced Budget and Emergency Deficit Control Act of 1985 (BBEDCA) is contingent upon the President subsequently so designating all such amounts and transmitting such designations to the Congress.

The Act provides a net total of \$20.5 billion in fiscal year (FY) 2018 emergency funding for hurricane and wildfire relief and recovery. This net amount includes \$18.7 billion for the Disaster Relief Fund account within the Federal Emergency Management Agency (FEMA) for disaster relief purposes. Of this amount, the Act makes available for transfer up to \$4.9 billion to FEMA's Disaster Assistance Direct Loan Program Account for assistance to local governments in providing essential services due to Hurricanes Harvey, Irma, or Maria. The overall total also includes \$576.5 million for efforts to respond to the devastating wildfires in the western United States, and makes available \$1.3 billion of contingency reserve funding under the Supplemental Nutrition Assistance Program for a grant to the Commonwealth of Puerto Rico for disaster nutrition assistance. Further, the Act cancels \$16 billion of debt obligation of FEMA's National Flood Insurance Program.

I recommend that you designate as an emergency requirement all funding so designated by the Congress in the Act pursuant to section 251(b)(2)(A) of BBEDCA, as outlined in the enclosed list of accounts. Upon transmittal of these designations to the Congress, these funds will be immediately available for obligation and expenditure. No further congressional action will be required.

The designation of these funds as emergency requirements allows for adjustments to the discretionary spending limits in FY 2018, as specified in section 251(b)(2)(A) of BBEDCA. These adjustments will be reflected when the Office of Management and Budget submits its final sequestration report for FY 2018 in accordance with section 254(f) of BBEDCA.

I have reviewed this proposed action and am satisfied it is necessary at this time. Therefore, I recommend that you make the requested funds available by signing the enclosed letters to the Speaker of the House of Representatives and the President of the Senate.


