Congress designated as an emergency requirement all funding in division B and additional funds in division D of the Continuing Appropriations Act, 2018 and Supplemental Appropriations for Disaster Relief Requirements Act, 2017 ("the Act"). Section 114(c) of division B of the Act provides that the availability of funding that is designated by the Congress as an emergency requirement pursuant to section 251(b)(2)(A) of the Balanced Budget and Emergency Deficit Control Act of 1985 (BBEDCA) is contingent upon the President subsequently so designating all such amounts and transmitting such designations to the Congress.

The Act provides a net total of \$15.25 billion in Fiscal Year (FY) 2017 emergency funding for the immediate impacts of Hurricane Harvey to ensure that the Federal Emergency Management Agency can meet all current needs, as well as be prepared for any additional disasters that require Federal assistance; to support the Small Business Administration's disaster loan program to help small businesses and homeowners begin to rebuild; and to assist the Department of Housing and Urban Development to support recovery efforts in areas most impacted by major disasters declared in 2017. This net amount also includes a rescission and reappropriation in FY 2017 of prior emergency balances for Hurricane Sandy response in the Department of Veterans Affairs for renovation and repairs. Additional FY 2018 emergency funds in the amount of \$0.4 billion are continued for the Departments of Agriculture and of the Interior to respond to wildfire suppression needs.

I recommend that you designate as an emergency requirement all funding so designated by the Congress in the Act pursuant to section 251(b)(2)(A) of BBEDCA, as outlined in the enclosed list of accounts. Upon transmittal of these designations to the Congress, these funds will be immediately available for obligation and expenditure. No further congressional action will be required.

The designation of these funds as emergency requirements allows for adjustments to the discretionary spending limits in FY 2017 and FY 2018, as specified in section 251(b)(2)(A) of BBEDCA. These adjustments will be reflected when the Office of Management and Budget submits its final sequestration report for FY 2018 in accordance with section 254(f) of BBEDCA.

I have reviewed this proposed action and am satisfied it is necessary at this time. Therefore, I recommend that you make the requested funds available by signing the enclosed letters to the Speaker of the House of Representatives and the President of the Senate.
