What They Are Saying | Trump Administration Announces Completion of Actions Under the Western Water PM

Yesterday, the White House Council on Environmental Quality joined the Departments of the Interior, Commerce, Energy, the U.S. Army Corps of Engineers, and the U.S. Environmental Protection Agency in announcing the completion of all actions directed by the October 2018 Presidential Memorandum on Promoting the Reliable Supply and Delivery of Water in the West (Western Water PM). Under President Trump's directive, agencies efficiently coordinated to complete the environmental reviews of major water infrastructure projects in California, Oregon, Washington, Idaho, and Montana, to meet the needs of agricultural communities and other water users within the region. The actions in the Western Water PM, which were completed in under two years, will support reliable water supplies for the American West and promote economic prosperity in the region. Members of Congress

Senate

Senator Jim Risch (ID): "Today's Record of Decision has been years in the making. This comprehensive review of the Columbia River System Operations affirms the critical importance of the four dams of the Lower Snake River to Idaho and the region's energy production, irrigation, flood risk, and economic success while balancing species recovery. I appreciate the Administration's commitment to western water and applaud its dedication to conducting a robust and thorough review on time."

Family Farm Alliance, Dan Keppen, Executive Director: "President Donald Trump in October 2018 signed a presidential memorandum intended to promote reliable water access in the West. That memo kick-started a series of actions intended to reduce regulatory burdens and promote more efficient environmental reviews of Western water infrastructure projects. President Trump's memo and this Administration's follow through will benefit Western farmers and ranchers whose livelihoods depend on federal water projects. It's a practical and assertive change to water management and species recovery that those producers deserve."

Jason Phillips, CEO, Friant Water Authority: "The signing of the 2018 Western Water Presidential Memorandum, and the actions and decisions that followed, are evidence that not since the 1950s has there been an Administration so focused, and so determined to address the chronic water challenges that the valley has been facing for decades.
